they had all been together. Grandfather and Grandmother Cleland have been married for 52 years, Mr. Cleland being 83 years old and Mrs. Cleland 75 years. Both were born in the state of New York, Mr. Cleland de-

scending directly from Irish ancestry and Mrs. Cleland from Puritan stock.

Mr. Cleland left New York for the gold fields of California on March 16, 1852, voyaging arond Cape Horn and arriving at San Francisco on July 16, 1852. After visiting a few of the camps below he started north and arrived in below he started north and arrived in Yreka in September, 1852, and has been here or hereabouts ever since, except for a trip back to the Empire state in 1855. The young man did not forget the love of his youth, and in '55 he took the long and arduous journey back to his old home, where he married Miss. Harriet Scovel, who is here today, the mother and grandmother of a long line. mother and grandmother of a long line of native sons and daughters.

Mr. Cleland is the last of his father's family. Only last spring his remaining sister and brother died within a few days of each other, leaving him the patriarch of the Cleland blood. He and his beloved consort are both hale and hearty and bid fair to remain among us yet for many years. Such is the wish of their host of friends.

# TAKES POISON TO JOIN WIFE IN DEATH

Perry Fisher Ends His Life When Informed That She Could Not Survive Illness.

WOMAN PASSED AWAY IN IGNORANCE OF TRAGEDY

Deceased Formerly Was One of the Most Prosperous Citizens of Denver.

That he might be with his wife in death, Perry Fisher, formerly a prominent real estate dealer in Denver and owner of once valuable mining properties, committed suicide in Sacramento, Cal., Monday by taking poison. He had been informed that his wife, whose health had been poor many months, could not survive.
"I will join her on the other side," he

He swallowed a dose of poison and died almost instantly. A few minutes later his aged wife passed away, not knowing of her husband's death.

News of the two deaths reached Clel-

News of the two deaths reached Clellan Fisher, their son, of 2546 South Logan avenue, yesterday. A daughter of the aged couple, Mrs. Frank Stockton, lives at 2348 Welton street. Full particulars had not been received by them last night. Mrs. Fisher had been suffering from neute heart trouble the last two years and her husband also was in feeble health. Mr. Fisher has been brooding over his financial losses since he left Denver, and it is thought that this in Denver, and it is thought that this, in a great measure, was the cause of his suicide. The entire fortune of Mr. Fisher was recently swept away and his holdings in California mining stocks, in which he had placed the remnant of his savings, were of an unstable nature.

Mr. Fisher formerly lived at Twenty-third and Welton streets. The family at that time was recognized as among the most wealthy in Denver Mr. Fisher furnished the backing for the construction of many of Denver's largest buildings. When Mr. and Mrs. Fisher left for Sacramento several years ago they left the control of their real estate interests to their son, Ciellan Fisher.

### Harriet "Hattie" Nelson (Fisher) Mitchell

Harriet "Hattie" Nelson Fisher was the second of ten children born on April 19, 1864 in Fountain City, Colorado to Perry William Fisher and Lucetta Coplen.<sup>1</sup> Hattie's father and several of his children were bigtime miners.<sup>2</sup> The Fisher family moved around Colorado, living in El Paso County in 1870, Hinsdale County in 1880, and in Denver by 1882. Hattie Fisher married Mortimer Hill in 1884 at her parents' home in Denver.<sup>3</sup> They had one child who lived to adulthood, Perry Jefferson Hill, born on December 18, 1885. By 1900, Hattie and her son Perry Hill lived with her parents at Denver.<sup>4</sup>

Hattie, her son, parents, and several siblings moved to Siskiyou County in 1901.<sup>5</sup> By 1903, they were associated with the Mount Vernon Gold Mine Company.<sup>6</sup> In 1905, Hattie's father gave her and W. H. Allison "one-fourth interest in Rose group of mines, consisting of the Nigger [sic] Boy, Mineral Slide, Ohio, Twalla and Excelsior mines on Ash Creek Cottonwood District." Also in 1905, "Mrs. Hattie Hill, a Colorado woman," married David Cuddihy, fellow miner and "proprietor of the old-time famous Cuddihy Hotel of Happy Camp."

In May 1907, Hattie's parents Perry and Lucetta Fisher died (see obituary p 3).<sup>9</sup> In 1907, after her parents' deaths, Hattie and David Cuddihy moved to Yreka,<sup>10</sup> and the following year they moved to Oak Bar.<sup>11</sup> Together, they owned the Bonanza placer claim in the Humbug district.<sup>12</sup> That year they worked the Side Hill and Lucky Jack placer claims in the Happy Camp district.<sup>13</sup> In 1909, Hattie and Emma J. Beard, wife of the Siskiyou County Superior Court judge, mined the Black Bird quartz mine in the Happy Camp district.<sup>14</sup> Later, Emma's daughter Susie Beard would visit Hattie when she moved to Humbug.<sup>15</sup>

By 1910, Hattie lived with her son Perry Hill on Humbug Creek, not far from her sister Bertha and her husband Oliver H. Poor. <sup>16</sup> Bertha (Fisher) Poor was involved in Eastern Star. <sup>17</sup> Although Perry had been

## Woman Prospector In Yreka Is Dead

YREKA (Siskiyou Co.), Dec. 5.— Siskiyou County lost one of her picturesque characters in the death of Mrs. Harriett Nelson Mitchel.

Mrs. Mitchel, who had spent the last thirty-four years in Siskiyou County, was a familiar figure in the mining world. Despite her advanced years she prospected during the Summer months, carrying her pick, shovel and gold pan far into the mountains.

Found Many Pockets.

Prospecting and mining was a hobby with her, which she turned to profit. She traced and took out many pockets in the Humbug section, some as high as \$2,000.

Mrs. Mitchel was the mother of Perry Hill, well known in forestry circles in this county. The funeral services were held to-day in the Kunz & Bills Funeral Chapel in Yreka. Interment was in the Evergreen Cemetery.

involved in mining when they first came to Siskiyou County, by this time he was a forest ranger. <sup>18</sup> Their relative Lotta Hill came all the way from Santa Rosa to visit them here. <sup>19</sup> In 1911, Hattie was working the Scribner Mine on the South Fork of Sucker Creek as well as the Red Cap Mine, a quartz claim, both in the Humbug district. <sup>20</sup> The newspaper noted, "Mrs. Hattie Cuddihy, one of Humbug's most successful pocket hunters, is getting some very rich ore at the Scribner Mine." <sup>21</sup> She sold her interest in the Rose group of mines to W. H. Allison. <sup>22</sup>

On Election Day in 1911, the male voters passed the Equal Suffrage Amendment, making California the sixth state in the Union to allow women to vote. Mrs. Hattie Cuddihy of Humbug was the first and Mrs. Maud E. Steele of Yreka second to register as a [female] voter in Siskiyou County. Mrs. In a 1911 paper, it was noted that Mrs. J. Cuddihy and Charles H. Mitchell of Humbug, stayed in a Yreka "caravansary. Mrs. The two of them married later that month. Hattie and Charles sold their Granite mines in the Humbug district, and Charles deeded half interest in his quartz claim at Humbug to Hattie in 1914.

By 1916, Hattie and Charles Mitchell lived at Orleans in Humboldt County, where he was a miner. <sup>28</sup> Charles was still in Humboldt County in 1920, where he was a fireman in a logging camp, but Hattie was not living with him. <sup>29</sup> She was back on her "mining claim on Humbug" by 1921. <sup>30</sup> Charles was back in Cecilville in 1922, <sup>31</sup> but he returned to Humboldt County in 1923. <sup>32</sup> Hattie remained at Humbug Creek and was still prospecting in 1930. She died on December 1, 1934 at Yreka, and is buried at Evergreen Cemetery with her parents and siblings. <sup>33</sup> Hattie's son died in 1938, and is also buried at Evergreen Cemetery. <sup>34</sup> Her third husband returned to Yreka where he died in 1946. <sup>35</sup> He is also buried at Evergreen Cemetery. <sup>36</sup>
